INTRODUCED BY _____

AN ORDINANCE TO AMEND SECTION 150.090 USER FEES OF CHAPTER 150 PARKS OF THE MUNICIPAL CODE OF THE CITY OF HERMANN.

WHEREAS, the City’s Park Board has recommended to the Board of Aldermen that it modify the Camping Fee Schedule provided in Section 150.090 of the Hermann Municipal Code (“Code”); and

WHEREAS, the camping fees currently charged per said Code section are as follows:

- Monthly fee for electric, water and sewer hookup ... \$600.00
(Hookups for more than one month are not allowed)
- Weekly fee for electric, water and sewer hookup.....\$175.00
- Electric, water and sewer hookup (one night) \$30.00
- Electric and water hookup (one night)..... \$25.00
- Electric hookup (one night)\$20.00
- Primitive tent camping at Riverfront Park.....\$5.00
- Tent camping (per tent).....\$15.00
- Tent camping, groups of 25-50 (per tent)\$8.00
- Tent camping, groups of more than 50 (per tent)\$5.00

The fees described above include the applicable City bed/camping tax; and

WHEREAS, the revised Camping Fee Schedule recommended by the Park Board is as provided below; and

WHEREAS, the Board of Aldermen has determined that revising the Camping Fee Schedule is in the best interests of the citizens of the City of Hermann, Missouri.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HERMANN, MISSOURI, AS FOLLOWS:

SECTION ONE: Subsection A.1. *Camping Fees* of Section 150.090 *Users Fees* of the Code is hereby revoked in its entirety and a new Subsection A.1. *Camping Fees* is substituted in lieu thereof to read as follows:

- Monthly fee for electric, water and sewer hookup ...\$750.00
(Hookups for more than one month are not allowed)
- Weekly fee for electric, water and sewer hookup.....\$210.00

Electric, water and sewer hookup (one night)\$35.00
 Electric hookup (one night)\$25.00
 Primitive tent camping at Riverfront Park\$5.00
 Tent camping (per tent).....\$15.00
 Tent camping, groups of 25-50 (per tent)\$8.00
 Tent camping, groups of more than 50 (per tent)\$5.00

The fees described above include the applicable City bed/camping tax.

SECTION TWO: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION THREE: This Ordinance shall be in full force and effect from and after its passage and adoption.

SECTION FOUR: The publisher of the City of Hermann ordinances shall be permitted to re-designate the section or sub-section number of this revised code section to fit within an appropriate portion of the Hermann City Code, within the discretion of the publisher.
