#### \*\*\*PERMITS REQUIRED\*\*\*

Per Ordinance #985, a permit is required for any sidewalk, curb and gutter, or driveway repair or replacement. Applications are available at the City Office.

Per Ordinance #1390, a building permit is required in compliance with International Building Code (BOCA). Forms are available in the human resource office.

### \*\*\*NEW UTILITY CUSTOMERS\*\*\*

A utility deposit for electric, water, and gas is required before service can be turned on or transferred. This deposit is held for <u>2 years</u>. If your account has been in good standing with the City, it will then be refunded back to you. If you happen to move before the 2 year period, the deposit will be put toward your final bill. If your final bill is less than your deposit total, the balance remaining will be refunded to you. If the final bill is more than your deposit total, the difference will be due from you. If you would be moving within the City your deposit will follow you to the new location.

### Deposits required for change of service

Electric & Water \$250.00 deposit (rental property) \$125.00 deposit (homeowner) Natural Gas \$150.00 deposit (rental property)

\$ 65.00 deposit (homeowner)

Commercial \$250.00 electric \$150.00 gas

Your bill includes charges for the electric, water, gas, sewer, refuse, and tax. (As of 07/10/19, the sewer will be \$23.75 service availability charge plus \$.0039 per every gallon of water consumed). Your bill will reflect a once a year charge for Missouri Primacy Fee and Missouri Sewer Fee (mandated by the state) We offer level billing for electric and gas (must have 12 month history) and meet eligibility requirements. We also offer (ACH) direct payment plan to our customers. (applications available)

Trash charge for any residential household is \$15.67 per month with an 8 bag limit per pickup. (07/10/19)

Please find attached a listing of the electric water & sewer rates for the City of Hermann. This is to give you an idea of how the utility bills are computed each month. Meters are read monthly (around the 10<sup>th</sup> of the month).

The City shall have access to your premises at all times in order to read the meters, inspect and make necessary repairs, and install or remove all City owned apparatus. You, the consumer, must keep the area around your meters easily accessible at all times.

If you should have a **natural gas emergency** or if you should smell a natural gas odor inside or outside, please call us immediately at **573-486-4500**. If the odor is strong, leave the premises immediately and call from a nearby phone to report the problem.

Should you anticipate any digging or excavation on your property; the Statutes of the State of Missouri require that you call **Missouri One-Call** at **1-800-344-7483 or 811** the **Nationwide number** at least <u>3 working days</u> prior to any work starting. They will notify all member utilities in the area to locate any underground utilities you may have on your property. You will be responsible for notifying any non-member utilities.

Please remember, you, the gas customer, assume all responsibility for the gas piping from the outlet side of the gas meter and all piping inside of the residence or building. All buried piping on the outlet side of the meter (the customer owned side) must be protected from and periodically inspected for leaks and corrosion. The customer is responsible for all appliances and proper venting. At the time of connection the customer will be notified of any unsafe conditions found in the residence or building by the City. The City reserves the right to terminate or discontinue service until such conditions are made safe and can pass City Standards.

Our office hours are 8:00 AM to 5:00 PM, Monday through Friday. We are closed weekends and holidays. We have a <u>Utility Payment Drop Box</u> located in front of the building at 1902 Jefferson St. and on the parking lot next to the new fire station at 214 East 2<sup>nd</sup> St.

The bills are due on the 15<sup>th</sup> of each month and are accepted if post-marked on or before the 15<sup>th</sup>. After the 15<sup>th</sup> the bill is considered delinquent and a 10% penalty will be assessed to the bill. Please make your check for utilities payable to "Hermann Municipal Utilities". We do send out a friendly reminder on the 16<sup>th</sup> of the month. If the bill is not paid in full by the 20th of the month, SERVICES WILL BE SHUT OFF! A RE-CONNECT FEE, ADDITIONAL DEPOSIT and ELECTRICAL INSPECTION are required per City Ordinance #1138, section 720.300 and sections 725.110 – 725-120 before any utilities are reconnected. (A copy of the ordinances is available per request.)

If you own dog(s) or cat(s), you must also purchase a City Dog/Cat License for each pet at a cost of \$1.00 per tag. You must have the rabies vaccination certificate in order to obtain a Dog/Cat License. These must be renewed each year. It is unlawful for the owner of a dog/cat, whether properly tagged or not, to permit or allow such dogs/cats to run at large within the City of Hermann, per Ordinance #798. Dogs must be on a leash when not confined.

\*\*Failure to purchase the above license could result in you being issued a ticket by the Hermann Police Department.

### Information on City of Hermann Fire Dues

### THIS IS NOT A BILL

OFFICIAL BILL TO BE SENT OUT IN JUNE EACH YEAR

Contributions to the Hermann Fire Company No. 1 Inc. for your property (or vehicle incident coverage for citizens that rent) within the Hermann City limits is <u>due by July 31 of every year</u>.

Many individuals do not realize the correlation between the strength of our Fire Department and our homeowner's insurance (ISO). The better equipped and trained our department is, the lower our ISO rates are. Our current ISO rating is 5 on a scale of 1 to 10. With that in mind, it's easy to see a direct benefit for citizen's when we help our department, especially by paying yearly dues to help fund tools and equipment they need when disaster strikes. Below is a chart showing how dues are figured for the residents and businesses within the City of Hermann.

False Alarms are \$100 per call after second call in any one year

The initial fire and/or accident call is \$100 plus \$500 for the first hour and \$500 for every hour or portion of an hour after the first hour to NON-MEMBERS. Homeowners paying dues covers both fire and vehicle incident.

**PAY RENT?** Please note that your landlord covers the dues for the property, but you are NOT covered in the case of a vehicle incident. To be covered you can pay \$40 a year.
