**AN ORDINANCE TO AMEND SECTION 150.090: *USER FEES OF THE MUNICIPAL CODE OF THE CITY OF HERMANN.***

WHEREAS, the City's Park Board has recommended changes to the user fees for certain City Park facilities; and

WHEREAS, the Board of Aldermen has approved the Park Board's recommended changes; and

WHEREAS, the Board of Aldermen desires to implement said changes by modifying the applicable City code provisions; and

WHEREAS, the Board of Aldermen has determined that the modification of certain City Park facility user fees is in the best interests of the citizens of the City of Hermann, Missouri.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HERMANN, MISSOURI, AS FOLLOWS:

**SECTION ONE:** Subsection (A) (11), *Rotunda Building* of Section 150.090 *User Fees* of the Code is hereby revoked in its entirety and a new Subsection 11. is substituted in lieu thereof, as follows:

11. *Rotunda Building*

- a. *One (1) Day Rental Fee:* The one (1) day rental fee is \$150.00.
- b. ~~*One (1) to Six (6) Hours (Resident User) Rental Fee.*~~ The rental fee is \$75.00.
- c. ~~*One (1) to Six (6) Hours (Non-Resident User) Rental Fee.*~~ The rental fee is \$100.00.
- d. ~~*Over six (6) hours (Resident User).*~~ The rental fee is \$200.00.
- e. ~~*Over six (6) hours (Non-Resident User).*~~ The rental fee is \$300.00.
- b. *Security/Cleaning Deposit:* A \$500.00 security/cleaning deposit is required.
- c. *Rental Fee for the Brush and Palette Club.* The rental fee for the Brush and Palette Club for any length of time shall be one dollar (\$1.00).

*d. Rental Agreement.* Rental shall comply with such other terms and conditions as may be provided in the rental agreement to be provided by the City Clerk.

**SECTION TWO:** A New Subsection shall be added to Code Section 150.090 (A) as follows:

13. *Sesquicentennial Park*

The rental fee per event within any one day is \$50.00.

**SECTION THREE:** Subsection B of Code Section 150.090 is hereby revoked in its entirety and a new Subsection B is substituted in lieu thereof, as follows:

B. The user fees designated for facilities described in paragraphs 2, 6, 7, 8, 9 and 10 of Subsection (A) hereof shall be adjusted to \$0.00 for any event conducted with in such facility by a not-for-profit organization with its principal office located within the City of Hermann and which holds a current exemption from payment of Missouri income and sales and use taxes, provided that such organization certify in writing at the time of applying for the reservation that the intended event is:

1. For the primary benefit of its members,
2. Of a type for which it was organized and for which the organization was granted the tax exemption, and
3. Not for the primary purpose of raising funds by the charging of an admission fee or by the sale of merchandise or services.

**SECTION FOUR:** All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

**SECTION FIVE:** This Ordinance shall be in full force and effect from and after its passage and adoption.

**SECTION SIX:** The publisher of the City of Hermann ordinances shall be permitted to re-designate the section or sub-section number of this revised code section to fit within an appropriate portion of the Hermann City Code, within the discretion of the publisher.
