AN ORDINANCE TO APPROVE THE EXECUTION OF A CONTRACT RENEWAL AGREEMENT WITH TRI-COUNTY TRUCKING AND EXCAVATING, INC., FOR SOLID WASTE COLLECTION AND DISPOSAL.

WHEREAS, on May 11, 2020, the Board of Aldermen passed Ordinance #2190 to approve a Contract for Solid Waste Collection and Disposal by and between the City of Hermann, Missouri and Tri-County Trucking and Excavating, Inc., (“Tri-County”); and

WHEREAS, the initial term of the Contract was for three (3) years, commencing on July 10, 2020 and terminating on July 9, 2023, both dates inclusive; and

WHEREAS, the Contract further provides that the City may extend the term of the Contract for up to three (3) additional one (1) year terms in the City’s discretion, provided that the Contract would be renewed only if the City and Tri-County would agree, in writing, with respect to the applicable percentage fee increase for such renewal term(s); and

WHEREAS, the City and Tri-County have agreed to extend the term of the Contract for one (1) additional one (1) year renewal term, commencing on July 10, 2024, and terminating on July 9, 2025, both dates inclusive. The rates to be paid to Tri County shall be increased by 3.5%. See the Contract Renewal Agreement between the City and Tri-County attached hereto as Exhibit A and incorporated herein by reference; and

WHEREAS, the Board of Aldermen has determined that the extension of the Contract Renewal Agreement would serve a legitimate public purpose and is in the best interests of the citizens of the City of Hermann, Missouri.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HERMANN, MISSOURI, AS FOLLOWS:

SECTION ONE: The Board of Aldermen does hereby approve the Contract Renewal Agreement. Mayor Bruce Cox is authorized and directed to execute the Contract Renewal Agreement on behalf of the City.

SECTION TWO: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION THREE: This Ordinance shall be in full force and effect from and after its passage and adoption.
